From the President

As we begin 2026, TAPA has already been laying the groundwork for a busy and significant legislative session. We will be advancing several insurance reform initiatives while also supporting the governor's efforts to strengthen rural healthcare delivery across Tennessee.

Rural Health Transformation (RHT) Program

You may have seen recent news coverage about the Rural Health Transformation (RHT) Program, which was created under the federal One Big Beautiful Bill Act passed by Congress last summer.

The RHT Program is a \$50 billion, five-year initiative to help states improve healthcare access, quality, and outcomes in rural communities. Its goals include preventing rural hospital closures, enhancing care delivery, and achieving long-term health improvements through state-driven, data-informed strategies.

Half of the funding will be distributed equally among approved states. The remaining 50 percent will be allocated based on factors determined by CMS, with a major emphasis on workforce development—specifically encouraging states to pass laws that allow rural providers to practice at the top of their licenses.

On Dec. 29, it was announced that Tennessee was approved for \$206,888,882 for 2026. However, to get (and keep) that full amount, Tennessee must pass legislation implementing the initiatives included in its RHT application submitted in November. So what does this mean for PAs?

Tennessee's application makes two important statements:

"Expanding the scopes of practice for physician assistants, nurse practitioners, pharmacists, and dental hygienists will help alleviate critical workforce shortages and enable more timely, accessible care for rural residents."

*"Physician Assistants: The source accurately reflects Tennessee's moderate scope of practice environment. **Tennessee will introduce and pass legislation in 2026 to enable optimal scope of practice. Implementation will occur by January 1, 2027.**"*

This is exciting news for our profession. It shows that the governor supports adopting Optimal Team Practice (OTP) for PAs in Tennessee. While we came close to passing OTP legislation in 2024, the governor's leadership significantly improves our chances of achieving full OTP in 2026.

Over the past two months, the governor's policy team has been working closely with TAPA and the AAPA to ensure that the proposed legislation aligns with the AAPA's definition of "optimal."

However, the passage of this bill isn't a sure thing. Physician groups are already mobilizing opposition, despite the fact that blocking this effort would reduce federal funding for rural communities. We anticipate a challenging legislative battle involving physicians, the governor, and House and Senate leadership. TAPA has gone on the record as strongly supporting the governor's initiative.

Insurance Reform

TAPA will also be focusing heavily on insurance reform this session. As discussed in our last newsletter, PAs are facing increasing pressure from insurance companies:

1. Blue Cross has announced it will reimburse PAs and APRNs at only 85 percent of physician rates.
2. Cigna and other insurers have implemented automatic downcoding of visits, significantly reducing legitimate reimbursement for services provided.

In response, TAPA's lobbyists have joined a broad coalition of providers, including the Tennessee Medical Association (TMA), other physician groups, nurses, and hospitals. This coalition is working together to push back against these harmful and unfair reimbursement practices.

The TMA is drafting a comprehensive bill to address several issues, including downcoding. In parallel, TAPA is collaborating with nursing

organizations and urgent care clinics to advocate for fair and equal reimbursement for services provided by PAs.

We are anticipating a busy PA Day on the Hill as we discuss these issues with legislators, so please mark your calendars for Wednesday, February 25. Take the day off from clinical practice and join your PA colleagues in Nashville as we meet with legislators to discuss the critical issues facing our profession.

Finally, thank you to all current TAPA members. Your engagement and dues provide the resources needed to advocate effectively for PAs across Tennessee.

If you have PA colleagues who are not yet members, please encourage them to join. There is strength in numbers, and this legislative session will require every PA in our state to be engaged and informed.

The 2025 award recipients reflect the very best of our community — from seasoned clinicians and educators to rising student leaders and dedicated preceptors. We are proud to recognize the following outstanding individuals.

PA of the Year: Natalie Stafford, PA-C

TAPA's 2025 PA of the Year, Natalie Stafford, exemplifies the highest standards of clinical excellence, integrity, and patient-centered care. Currently serving as Lead Advanced Practice Provider at Resolve Pain Solutions, and formerly a key provider at Mays & Schnapp Neurospine and Pain, Natalie has made a profound impact on patients navigating complex pain management.

Known for her compassion and attentive listening, Natalie partners closely with her patients to understand their goals and deliver personalized, evidence-based care. Her commitment to diagnostic accuracy, risk reduction, and safe opioid prescribing has led her to champion non-pharmacologic therapies and thoughtful de-prescribing strategies that promote long-term wellness.

Beyond the clinic, Natalie's leadership has influenced care across the state. In late 2024 and early 2025, she served on a statewide task force through the Tennessee Medical Association and the Opioid Abatement Committee, helping update

continuing education for prescribers statewide. Her ability to navigate complex and sensitive topics made her a trusted and influential voice.

Natalie also serves on the TAPA Board of Directors as a Director At-large and represented Tennessee nationally as a delegate (2023) and an alternate delegate (2024) to the AAPA House of Delegates. Her dedication extends into the community, where she serves as a Team Leader at Oikos Church, organizes diaper drives, provides meals to college students, volunteers monthly with Freedom Prayer, and lectures at UTHSC, educating PA students on safe opioid prescribing.

As a mentor and advocate, Natalie supports the onboarding and professional growth of both PAs and NPs, fostering a supportive and collaborative practice environment. Widely respected by colleagues across disciplines, her leadership continues to shape the future of PA practice in Tennessee.

Student of the Year: Paxton Barnes

TAPA is proud to recognize Paxton Barnes as the 2025 Student of the Year — a rising star whose

leadership, work ethic, and heart for service embody the promise of the PA profession.

Paxton is currently a student in the Milligan University PA Program, where she began her studies in January 2024. In a short time, she has distinguished herself academically, clinically, and as a leader among her peers.

Her journey to PA school reflects discipline and determination. 2025 PA Foundation Report

2025 marked the 49th annual FallFest conference in Gatlinburg during the week of Oct. 6-10 and thanks to many wonderful donors to the Tennessee PA Foundation, a total of \$8,650 was awarded to deserving students from PA programs across the state of Tennessee.

Once again, all of our scholarship recipients sent in exceptional applications describing their academic achievements, community service, financial needs, future goals and aspirations, and an essay about their decision to pursue becoming a PA. We had many more deserving students than funds, but the TAPA Board of Directors and PA Foundation Committee made the best decisions possible with the information we were given by the applicants.

The annual James Montag, Jr. Military Service Scholarship goes to deserving student applicants who have served in our military branches prior to entering PA Programs. This year, two scholarships were awarded to students of the MTSU PA Program. The first scholarship went to Whitney Smith, who served for four years as an Army Surgical Tech. The second scholarship was awarded to Jesse Scobee, who served in the Navy on the USS Arlington. Each student received a \$1,200 scholarship through the generosity of James Montag, Jr.

The J.C. Carey Memorial Scholarships is given in honor of J.C. Carey who lived a life of service as a Tennessee PA. He was a patient healthcare provider, teacher, preceptor/mentor, and TAPA Board member during his career. This year, six

scholarships were awarded to the following Tennessee PA students: Rachel Simon of Bethel University (\$500), Meaghan Robinson of South College (\$500), Whitney Smith of MTSU (\$500), Rachel Nall of Lincoln Memorial University (\$1000), Andrew Northway of Milligan University (\$1,000), and Cassandra Roberts of Bethel University (\$1500).

New this year was a memorial scholarship in honor of the life and service of Steve Clifton who served his patients well throughout his career. Steve was a regular CME speaker at conferences and dinner meetings. He was also a student preceptor/mentor, served for several terms on the TAPA Board of Directors, and was a long-time member of TAPA's CME Committee - being instrumental in organizing and overseeing the Exhibit Hall at many TAPA conferences. Always a friendly, calm and encouraging PA, his mark on our profession leaves a lasting legacy which will carry on in patients' lives, students and all who knew him. This scholarship was started and funded by Joan Gardner and Travis Lane this year.

The inaugural Steve Clifton memorial scholarships were awarded to Rachel Nall of Lincoln Memorial University (\$500) and Olivia Ann Philips of MTSU (\$750).

Thank you again to all who donated to the PA Foundation in 2025! You have given great gifts which assist PA students in pursuit of their education in order to obtain careers which we have all been blessed with, and they too will serve others, change peoples' lives, make friends for life, and find satisfaction and rewards well beyond the monetary benefits of this career.
