# **Legislative Update**

Last year, TAPA had an extremely successful legislative session – passing both the PA Compact bill and the PA Practice Act bill. This was the culmination of many years of hard work by PAs who attended PA Day on the Hill, lobbied legislators, and mobilized in districts across the state to support legislative candidates who supported PAs.

Because of last year's successes, TAPA did not introduce PA-specific legislation this year. Instead, the Academy's focus has been on implementing the bills that were passed in 2024.

In previous issues of TAPA's *PA Pulse*, TAPA President Marie Patterson has reported on the activities of the national PA Compact Commission as they work to create the infrastructure necessary to establish the national compact. Dr. Patterson is Tennessee's representative to the PA Compact Commission. And as one of the few PAs serving on the commission, her voice is an important one in ensuring that practicing PAs have a voice in establishing the rules and regulations of the commission.

With regard to the bill passed in 2024 making changes to Tennessee's PA Practice Act, work has progressed on the rules that must be adopted to implement the changes. There are two sets of rules that must be adopted.

The first set of rules will specifically address "collaborative agreements" that PAs with the endorsement will practice under instead of the traditional protocol. Per the new statute, these rules will be promulgated and adopted by a task

force made up of one (1) member from the board of medical examiners; one (1) member from the board of osteopathic examination; one (1) member from the board of pediatric medical examiners; and three (3) members from the board of physician assistants. This task force met twice and approved the draft rules at their meeting on Dec. 13, 2024.

These draft rules will now make their way through the rulemaking process, with the final stop being the rulemaking hearing in front of the task force. Once the rules are adopted at the rulemaking hearing and approved by the Attorney General and Governor, they will become effective and all parts of the bill passed in 2024 will go into effect. The rulemaking hearing is expected sometime mid-year.

The second set of rules will implement the endorsement application and process, as well incorporating other sections of the new law. The Board of PAs has been working on the draft rules, and they are expected to adopt that draft at their upcoming meeting on April 4.

eligible for the 50-percent bonus awarded by the NCCPA when they are logged, giving attendees a total of 9 CME credits once the bonus is applied by the NCCPA.

The PA scope of practice is decided at the state level, so it is imperative to elect members of the General Assembly who appreciate and support the PA profession and understand how a robust practice act enables PAs to improve access to care for Tennesseans.

TAPA's PAC is important because it collects contributions from PAs and bundles those them into larger campaign contributions. This enables TAPA to give financial support to those candidates that support PAs and the PA profession.

The General Assembly will soon adjourn for the year and while this is not an election year, legislators will be calling on TAPA to donate to their 2026 campaigns. It is important for TAPA to have a wellfunded PAC account in order to extend TAPA's influence and support our friends.

Many PAs contribute to the PAC when they pay their membership renewals, and that is wonderful! These contributions have helped TAPA to build up the PAC over the years. However, it's the recurring contributions that really build the foundation of the PAC and create a dependable revenue stream.

On the right is a list of PAC contributors, and you'll see many names with an asterisk by them. These are the TAPA members who have signed up for regular contributions to the PAC.

An automatic donation is charged to the credit card on file, which makes it easy and convenient to support the PAC. Even a modest contribution of \$25 a quarter adds up to \$100 per year, or \$25 a month adds up to \$300 at the end of the year. Many of our recurring donors give \$50 each month, which really helps to build our PAC!
